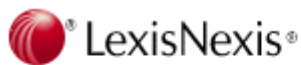

CaseMap is a fact management application used to manage, organize and connect case facts, legal issues, key players and documents. CaseMap integrates with over 30 litigation review applications including Acrobat and Summation, allowing facts identified on documents within these applications to be sent directly to CaseMap. Reports can be easily produced and greatly aid in standardizing work flow and can give team members a snapshot of critical case detail including an outline of issues for the case, a fact chronology and all supporting people, organizations and documents in the case.

TimeMap is a timeline graphing software that enables the user to create a timeline of events from critical case details. Visual timelines make it easy for the litigation team, witnesses, clients, the judge, jurors and other key players to understand the sequence of events in a case. TimeMap integrates with CaseMap such that any records in CaseMap that have a date association can be sent to TimeMap for an instant timeline of events.

The DocPreviewer allows litigation teams to maximize efficiency by leveraging the enhanced integration between CaseMap and Adobe Acrobat. DocPreviewer converts PST files (Outlook emails) to PDF, Bates Stamp PDFs and bulk import PDFs into CaseMap. The Doc The ability to convert PST files to PDF has an added layer of functionality which pulls sender and recipient names into CaseMap automatically, adding all the names to the person's spreadsheet.
